

# Community Development Block Grant "a program"

Several months ago, members of the Civic Improvement Committee met to discuss several worthwhile projects which could be recommended for funding under the City's Housing and Community Development Block Grant Program. Since Hiltonia is not directly eligible for assistance (by virtue of its not being a low income neighborhood), a project was conceived for another area in the West Ward which would not only benefit Hiltonia, but the remainder of the City as well. Basically, the project calls for the rehabilitation and resale of now vacant and abandoned buildings. The purpose, of course, is to attract stable, moderate income families to the West Ward and to return these buildings to the tax rolls.

The idea was presented at a meeting of the general membership for approval. Afterward, it was presented to several other West Ward Associations for their input and approval. It was at this time that the proposed target area was formalized. The group settled upon Colonia Avenue (see map) which is located perpendicular to West State Street and included as part of the Hermitage House Civic Association.

Since a project of this magnitude requires a broad base of support in order to succeed, it was presented to the Trenton Council of Civic Associations for endorsement. A representative of the City urged that the TCCA NOT endorse the plan, but endorse a similar city-sponsored plan instead.

Another committee was established to compare details of each plan and to make a recommendation. The issue was resolved in the following way: the TCCA and it's members would agree to the City's plan if the City agreed to increase it's proposed budget to at least \$200,000 and to select Colonial Avenue as the target area. The TCCA, via a poll of the Presidents, even agreed to sponsor the program for the City.

On January 7, the proposal was presented to City Council at their final hearing on the Community Development Block Grant Program. Numerous groups supported it and we are awaiting word of the City Council's decision.

#### Tips:


Be sure your windows are locked and fixed so they cannot be easily broken, unlatched and raised.


## **PLUSES AND MINUSES**


The committees have not yet been appointed, but they will appear in the next Hilltone.

## THE HOLIDAYS IN HILTONIA

The Holidays were a busy time for most Hiltonians and a busy time for the Hiltonia Association. The following articles will tell you about the Hiltonia Holiday Season.

# Hiltonia General Membership Meeting December 16, 1980

The 4th general membership meeting for 1980 was held on Tuesday, December 16, 1980 at the home of Bob and Mary Sue Topper. Mayor Authur Holland was the evening's guest speaker. The question and answer format was used and the following issues were discussed:

New Jersey is the 2nd in the nation on it's reliance on the local property tax. In an area like Trenton, with a socio-economic imbalance, the local property tax is high.



Mayor Holland favored a statewide uniform property tax in order to share the welfare burden, so that it becomes manageable.

The tax base in Trenton is shifting from local manufacturing to government. The first inlieu of tax payments from the State were received in 1962 and this year the City received \$1.4 M from the State. However, this is not a guaranteed payment since it is voted on annually. The money received never pays for the services that the City provides.

Re-evaluation is going out to bid in January. The bid will buy the city a tax system so that re-evaluation will never have to be done again since the new system will have the ability to be kept updated. A lot of the leg work is expected to be done by CETA employees. At the next meeting of the Trenton Council of Civic Associations on February 11, Jim Vroonland will speak about the re-evaluation process, what the tax payers rights are, and what the appeal process is. The Mayor said that you do not need to let people in your house, however, they can assume that the inside is better than the outside.

A discussion on Historic Preservation followed. The Mercer Hospital Project, Chambersburg Mall, and the Lamberton Street Sewer were some of the projects that cost the City time and money because of Historic Preservation. For example, the Lamberton Street Sewer had to be rerouted in order to preserve the original sewer pipe because of it's historic design. Historic Preservation is not always bad as is seen in the opening of the Eagle Tavern.

## WINTER GARDEN TIP

"Sow in the Snow" - Grass seed should be thrown on top of the last snow fall. In this time of low rainfall it may be the only way to get the ground wet enough for the grass to grow.

#### Weather Watch!

If you hold on to your utility rate schedules, we will try to locate some information on your heating needs and how to compute any savings you may be seeing due to improvements in your home. Have you added insulation, weather stripping, storm windows, day-night thermostats, or something else? How do you know what you saved?


We have all been given percentages of savings for certain improvements. 20% here, another 30% on something else. If you add up the percentages you might reach 100% which can't be. We need to have some heat. In the next Hilltone we will try to supply you with the data you need to compute your savings.

Don't be discouraged if you're using more this year. It's been a cold, cold winter.

The following table compares degree days (the difference of a day's average temperature from the norm of 65°) for the months of September through December for the past 5 years. Remember 1976-77 was our last very cold winter and 1977-78 was our very snowy winter. We will continue to complete this chart in the next two issues.

### SAVE THIS PAGE FOR REFERENCE

With the cost of all utilities on the rise, they are becoming a major part of a lot of people's budgets. It might be helpful to have some information on the different rates and how the increases have affected you. The following paragraphs will show you the electric, gas and oil rates and their increases. The numbers in () are for example purposes.

#### Natural Gas:

RATES	Service Charge	1st 26 therms	Over 26 therms
Up 'til April 17, 1980	4.60	.3573*	.32°
After April 17, 1980	5.50	.45067°	.41765°

Compute you bill (example based on 60CCF)

- You need to know the number of therms used. Multiply the number of cubic feet (CCF) (60) x 1.02 5 61.20 therms.
- Multiply the number of therms by the Fuel Adjustment Factor(from your bill) per therm (61.20 x .098371)

3. Multiply the first 26 therms or less by the rate (26 x .45067) 11.72

4. Multiply the remainder of the therms (60-26) by the rate (34 x .41765) 14.20

5 . Add on the service charge 5.50

6. Add the above for your bill \$37.44

By repeating the process with last years rates, you bill would be

\$28.75

6.02

Your increase is 30%. If you use the same number of therms as last year your bill will be 30% higher.



#### **Electric:**

Your increase is 27%.

Now repeat the process using the summer rate and assuming that the fuel adjustment factor will remain constant. Your bill will be

This represents an 8% increase over the winter rates. Note: We usually use less electricity in the summer.
